# **COMPANY SECRETARIAL SERVICE**

### **Introduction**

When operating your business through a Limited Company there is a legal requirement, as laid out in the 'Companies Act 2006', to keep a record of certain events in what are known as the 'Statutory Books' of the company. These records have to adhere to formats laid down by law, and in certain cases specific documents have to be filed with 'Companies House' in a pre-defined format.
